Notes

- Any fee (except the security deposit), once received, will NOT be refunded under any circumstances. In case a student withdraws from a Course, no application for refund of fee will be entertained for whatsoever reasons.
- The NTU Validation Fee is payable at Rs.13,000/- per annum at the beginning of each academic year.
- A non-refundable, one-time Alumni Fee (Lifetime Membership Fee) of Rs.2,000/- is payable at the time of admission.
- At the time of admission, students are required to pay Registration & Admission Fee, Alumni Fee and Security Deposit, in addition to Tuition Fee, Laboratory/Library Charges and Examination Fee for Semester One. Subsequent installments are to be paid 10 days before the commencement of each Semester. The Validation Fee (as applicable) is to be paid for the full academic year, as mentioned above. *Sponsored / foreign candidates are required to pay all fees in advance on a per annum basis.*
- A refundable security deposit of Rs.5,000/- is compulsory for all Courses. The security deposit will be refunded only after the completion of the relevant Course, and after adjustment of all dues, if any. In case a student withdraws from a Course before its completion, no application will be entertained for refunding the security deposit till the formal completion of the Course as per its schedule.
- Statutory tax, such as service tax and any other, as applicable, imposed by the Govt. of India or any other statutory body, will be charged extra.
